Pre-K Counts Agreement

I would like to enroll my child, _____,

*(if your child is attending the Pre-K Counts program from 8:30am to 3pm **only**, no tuition is applied)

Read the following Agreement Details carefully:

- * If changes are needed to the above schedule, the director must approve them a week in advance.
- * Weekly tuition fees are due the week of charge. The tuition account can be pre-paid in advance. Late payment fee is \$25 per week late.
- * Written notice is required two weeks prior to withdrawal. If this notice is not given, tuition for two additional weeks after withdrawal must be paid.
- * Should the director determine that the child has to be suspended or expelled, you will receive a notice a week in advance of the suspension or expulsion and termination of the agreement.
- * All tuition is based on the Regular Hours of Operation (7am – 6pm). Registration is available for the Extended program. **Late fee** for late pickup is assessed based on the Extended Program daily fee.
- * Tuition fee is structured to compensate for the holidays and you will not be entitled to any credit for those days. A full week's tuition will be charged during those weeks.
- * Children who are enrolled on a part-time basis may not switch days to compensate for a holiday, illness, snow day, or any other reason without the consent of the director.
- * Toddler and preschool classrooms begin curriculum at 8:30am. We ask that you have your child here by that time. Please do not ask the Center or the teacher to hold breakfast for your child after 8:30am and avoid bringing the child to the Center during naptime.
- * Call the Center no later than 10:00am if your child is going to be absent that day. To qualify for the missed day tuition deduction, a notice 24 hours prior to the absence is required.
- * Should problems occur at the Center or irregularities be noticed, you should report them to the classroom teacher or the Center's director.
- * Do not bring ill children to the Center and if your child becomes ill at the Center, please pick the child up immediately.
- * Land of Children Center will not be responsible or held liable for items brought to the Center that are lost, stolen, or damaged. Parents are urged not to send valuables, money, jewelry, or toys to the Center.
- * Children are released **only** to an authorized parent/guardian or a person authorized by permission from the parent (with a picture I.D. and/or other identification, 18 years of age or older).
- * Child will not be released to an authorized pick-up person, including the parent, should the Center's staff suspect this person to be under the influence of drugs or alcohol.
- * The Center cannot legally restrict the non-custodial parent from visiting the child, reviewing the child's records, or picking up the child unless the Center has been provided with current legal documents.
- * Land of Children Center is not responsible for children before they arrive and after they leave the program and outside of their registered Enrollment Time.

Pre-K Counts Enrollment Options and Tuition Agreement

Children enrolled in Pre-K Counts, a free program from 8:30am – 3pm, have the option to also enroll in the Land of Children Daycare and Private school, before and/or after the Pre-K Counts program and during the program's off-days.

Before Care (7am – 8:30am)	
5 Days (full week)	\$35
Per Day (part time)	\$10
After Care (3pm – 6pm)	
5 Days (full week)	\$90
Per Day (part time)	\$20
Full Time with Pre-K Counts between (7am – 8:30am) & (3pm – 6pm)	
5 Days (full week)	\$120
Per Day (part time)	\$30
Full Time when Pre-K Counts is off (7am – 6pm)	
5 Days (full week)	\$195
Per Day (part time)	\$40

- * Families with two or more children attending FULL TIME will receive a 10% discount for each **additional** child.
- * Missing days (days registered for) are calculated as part time if the center is notified before absence. Without notice, full tuition is applied for the missed day. Day's tuition is calculated based on the number of days registered for.
- * One week of vacation time per year per child is tuition free.
- * Weekly tuition can be paid at the beginning or the end of the week. Late fee is \$25 per week. Unpaid tuition accounts may result in dismissal and legal action.
- * All tuition is based on the Regular Hours of Operation (7am – 6pm). Extended program from 6pm to 7pm. Registration is available for the Extended program. **Late fee** for late pickup is assessed based on the Extended program daily fee.
